### Camping Facilities Use Agreement

This Agreement is made and entered into between Delaware County, the Delaware County Commissioners, the Delaware County Fair Board and the Delaware County Fairgrounds (“Fairgrounds”)

2. Facilities Users agrees that it shall exercise reasonable care in the conduct of its activities at such facility, shall follow any and all reasonable rules and regulations set forth by Fairgrounds.
3. Facilities User shall indemnify and hold harmless the Fairgrounds from any and all liability for any and all actions, claims, losses, costs and expenses, including but not limited to attorneys fees, in any manner arising from the use of the facilities by \_\_\_\_\_ or its members.

  - B. To assume responsibility for any damages done to the facilities beyond normal wear and tear, except for acts of vandalism and other events, not the fault of Facilities Users, covered by the Fairground's Insurance:

  - D. All keys must be returned to the Fairgrounds at the conclusion of Facilities User Event.
5. Specifically prohibited are any activities that are discriminatory, that may violate the canons of good moral, manners or taste, or be injurious to the building, grounds, or equipment, that promulgate any theory or doctrine subversive to the laws of Indiana or of the United States, that advocate governmental change by violence, or that promote partisan politics, or that promote a particular religion.
6. This agreement shall be interpreted in accordance with Indiana law.

#### **Campground Rules**

Campsites are based on one camper unit, tent, pop-up, trailer, motor home and four people per site. Extra tents, if for your DEPENDENT CHILDREN, are \$5.00 per night. All other tents or camping units are charged as a separate site. Reservations do not guarantee a particular site. We try to give the site requested: however, your reservation may be moved to another site.

Park in front of your camper. If you have extra vehicles, they may be parked in one of the parking lots based upon availability. No more than 2 vehicles per site. No parking on vacant sites.

Do not leave trash out overnight. Trash may be placed in dumpsters or trash containers provided at any time. You are responsible for always keeping your site clean.

The speed limit is 10 MPH on the main road and 10 MPH in campground.

Alcohol is not permitted outside your campsite. Absolutely no alcohol in any public area. Misuse of alcohol will not be tolerated and could be cause for dismissal,

Smoking is not allowed in any building, including restrooms and grandstand. Please dispose of smoking materials properly.

All dogs must be kept in campsite or must use a leash when leaving site.

**NO CAMPFIRES ARE PERMITTED**

No ATV off road Vehicles or Dirt Bikes is Permitted.

No Washing of Motor Home, Trailer, cars are permitted.

No Dish washing in bathrooms are permitted.

Sewage Disposal is free if you are renting.
